§ 5(2)(b)	Minimum number of ECTS credits or minimum number of majors allowing a student to pass a semester/year conditionally and to be enrolled in the next semester/year of study,	If the settlement period is an academic year, a student who has obtained at least 50 ECTS credits in a given academic year for the completion of majors included in the programme of a given year of study may apply for conditional completion of a given year and, if accepted, shall be enrolled in the following year of study. Failure to pass the missing major(s) in the year in which the student is enrolled will result in the requirement for the student to repeat that year;
§ 5(2)(c)	Applicable sequence of subjects	<p>A student repeating a year of study has the right to pass majors from the following year of study, with the exception of:</p> <ul style="list-style-type: none"> - administrative proceedings and administrative court proceedings if he or she has failed the administrative law examination, - civil law - part two, if he has not passed the civil law examination - part one, - criminal proceedings if he or she has failed the criminal law examination, - civil procedure and business and commercial law if he or she has not passed the civil law examination, - administrative law - the specific part and local government law, if he or she has not passed the examination in administrative law - the general part;

§ 5(2)(d)	Mandatory subjects without passing of which a student may not be enrolled in the next semester/year of study, regardless of the score obtained	In spite of obtaining 50 ECTS scores, due to the need to maintain the sequence of majors, the student cannot be enrolled: - in the third year of law, if he or she has not passed the examination in administrative law, civil law - part one, criminal law, constitutional law, - in the fourth year of law, if he or she has not passed the civil law examination - part two, - in the third year of administration, if he or she has not passed the administrative law examination - general part;
§ 5(2)(e)	Rules other than those provided for in § 23 of these Regulations for the transfer of students from full-time to part-time study or vice versa, rules applicable to the whole faculty or to individual majors	A part-time student may be transferred to full-time study if: - he/she has attained the average score of the course of study to date of at least 4.75 after completing the second year of study, - he/she has attained the average score of the course of study to date of at least 4.50 after completing the third year of study, - he/she has attained the average score of at least 4.75 after completing the first year of the second degree studies.
§ 5(2)(f)	ECTS credit conversion rates for individual majors and specialities where the exchange of students with foreign or national institutions does not guarantee the equivalence of student achievements	none
§ 5(2)(g)	Possibility to apply from the first semester in the second degree study programme for an individual study plan and curriculum (IPS),	Students with an average score of at least 4.2 in their course of study to date may apply for an individual study plan and curriculum (IPS);
§ 5(2)(h)	Rules other than provided for in § 38(7) and (8) for the completion of a course of study	A request for promotion can only refer to a subject from the next (immediately higher) year of study if the credit period is an academic year. A request for promotion should be submitted no later than one month after the start of classes in the major concerned. Postponement by the dean of the deadline for passing an examination or the final course credit shall not suspend the deadline for the submission of the request for promotion. A request for deletion/resignation from promotion may be submitted no later than by 30 November in the winter semester and by 31 March in the summer semester of the relevant academic year. A student who has failed a course in promotion shall repeat it in the year of study in whose curriculum the course is included. In such a situation, repeating of a course is subject to payment in accordance with the relevant regulation of the Rector of the University of Lodz. A grade obtained without permission for promotion is not taken into account in the credit for the year.

		A student repeating a year of study has the right to obtain credit for subjects from the next (immediately higher) year of study in addition to the subjects included in the study plan for the year in which he/she is enrolled, while observing the sequence of subjects in force at the Faculty of Law and Administration at the University of Lodz, as specified in this annex pursuant to § 5(2)(c) of the Study Regulations.
